CASE MANAGEMENT ORDER NO. 8

For the purposes of the proceedings before the Special Master, IT IS HEREBY ORDERED THAT:

(1) Oral Argument on Motion to Intervene. Oral argument on the motion to intervene is scheduled for Tuesday, September 11, 2001, at 10:00 a.m. The argument will take place at the George Washington University Law School, 20th & H Street, N.W., Washington, D.C. The room number will be announced later.

(2) Supplemental briefing. The proposed intervenors have until July 3, 2001, to file a supplemental brief. Alaska and the United States have until August 3, 2001, to file their separate responses. The proposed intervenors have until August 17, 2001, to file a reply. Briefs should follow the form specified in Appendix D of the Comprehensive Case Management Plan (which is available at www.law.gwu.edu/facweb/gmaggs/128orig/docket.htm).

(3) Unpublished Documents. The proposed intervenors have suggested in their motion papers that the position taken by the United States in the case of Peratrovich v. United States, No. A92-734-CV (D. Alaska), is relevant to the question of intervention in this case. To ensure the compiling of an appropriate record upon which the Special Master and ultimately the Supreme Court can determine the question of intervention, the Special Master requests that the proposed intervenors and/or the parties provide him with copies of the following documents from the Peratrovich case: (a) the pleadings, (b) any motion for an injunction plus the briefs in support and opposition, (c) any dispositive motion plus the briefs in support and opposition, and (d) any other document which any party in this case or the proposed intervenors believes could usefully contribute to the compiling of a record for the determination of the intervention

motion. The parties and proposed intervenors also will supply copies of any other unpublished documents cited in their briefs.

(4) Alaska Site Visit. The parties and proposed intervenors will confer and determine their points of agreement and disagreement with regard to the scheduled Alaska site visit and notify the Special Master by letter.
